In the reference 7<sup>th</sup> read above, the Vice Chairman, Visakhapatnam Urban Development Authority has reported that a Press Notification has been issued on 07.08.2013 in two Daily News Papers of Sakshi and the New Indian Express calling objections and no objections have been received within the stipulated period and also reported that the applicant has paid an amount of `1,25,63,186/- towards conversion charges. **NOTIFICATION**

In exercise of the powers conferred by sub-section (2) of Section 12 of Andhra Pradesh Urban (Development) Areas Act, 1975 (Act-I of 1975) read with Rule 13-A of Urban Development Authority (Visakhapatnam) Rules, 1977, the Government hereby makes the following variation to the land use envisaged in the Master Plan for Visakhapatnam Metropolitan Region-2021, the same having been previously published in the Extraordinary issue of Andhra Pradesh Gazette No.569, Part-I, dt.08.08.2013 as required by sub-section (3) of the said section.

VARIATION

The site falling in Survey Nos.212/p, 215/p, 222/p, 223/p, 224/p, 228/p of Aganampudi (V), Gajuwaka (M), Visakhapatnam District to an extent of Ac.77.12 cents, the boundaries of which are given in the schedule below, which is presently earmarked for Industrial Use in the Zonal Development Plan of Visakhapatnam, sanctioned in G.O.Ms.No.345 M.A. & U.D. (H2) Department, dt.30.06.2006 is now designated as Institutional land use by variation of change of land use, as the proposed site is abutting the existing NH-16 and the site was allotted by the Government and the applicant Institution i.e., Tata Memorial Centre is under the administrative control of Atomic Energy, Government of India, as shown in Map No.22/2013, which is available in the office of the Visakhapatnam Urban Development Authority, Visakhapatnam, subject to the following conditions; namely:-

1. That the applicant shall hand over the land for road widening if any on free of cost to the concerned authority through Registered Gift Deed.
2. That the applicant shall obtain approval of building plans for construction of buildings from GVMC, Visakhapatnam duly paying necessary charges to GVMC and VUDA as per rules in force.
- 3 That the title and Urban Land Ceiling / Agricultural Land Ceiling aspect shall be scrupulously examined by the concerned authorities i.e., Visakhapatnam Urban Development Authority/Greater Visakhapatnam Municipal Corporation before issue of building permission / development permission, and it must be ensured that the best financial interests of the Government are preserved.
4. The owners / applicants are solely responsible for any misrepresentation with regard to ownership / title, Urban Land Ceiling Clearances etc. The owners / applicants shall be responsible for any damage claimed by any one on account of change of land use proposed.
5. After approval of the change of land use the applicant have to apply to Visakhapatnam Urban Development Authority for necessary development permission duly paying the charges / fees to VUDA.
6. The change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976.
7. Any other conditions as may be imposed by Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam.

SCHEDULE OF BOUNDARIES

- North : Rehabilitation residential colony and APIIC lands.  
East : 24.30 Mtrs. wide road.  
South : 80 Mtrs. wide roadNH05 (NH-16) and vacant land.  
West : Private land and 9.14 Mtrs. road.
