In the letter 5<sup>th</sup> read above the Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam has reported that the draft variation notification was published in two Daily News Papers, calling for objections & suggestions and upon publication of notification no objections and suggestions received from the public within the stipulated period and also informed that the applicant has paid an amount of Rs.82,359/- towards land use conversion charges. Hence, the draft variation is confirmed.

APPENDIX  
NOTIFICATION

The following variation to the land use envisaged in the ZDP/Master Plan of Visakhapatnam which was sanctioned in G.O.Ms.No.345 M.A. & U.D. (H2) Department, Dated:30.06.2006, is proposed in exercise of the powers conferred by Sub-section (2) of Section 12 of Andhra Pradesh Urban Areas (Development) Act, 1975 (Act-I of 1975) read with Rule 13-A of Urban Development Authority (Visakhapatnam) Rules, 1977 is hereby published as required by Sub-section (2) of the said Section.

VARIATION

The site falling in Ts.No.68/P of Waltair Ward (V), Visakhapatnam Urban (M), Visakhapatnam to an extent of 654.23 Sq.Mts, the boundaries of which are given in the schedule below, which is presently earmarked for Residential Use in the Zonal Development Plan/ Master Plan of Visakhapatnam, sanctioned in G.O.Ms.No.345 M.A. & U.D. (H2) Department, Dt.30.06.2006 is now designated as Commercial land use by variation of change of land use, as the proposed site is surrounded by shops, malls, hospitals, residential apartments and schools which was shown in Zonal Development Plan/ Master Plan which is available in the office of the Visakhapatnam Urban Development Authority, Visakhapatnam, subject to the following conditions; namely:-

1. That the concerned shall hand over the land for road widening if any, on free of cost to the concerned authority through Registered Gift Deed.
2. The owners / applicants/ concerned, are solely responsible for any misrepresentation with regard to ownership / title, Urban Land Ceiling Clearances etc. The owners / applicants/ concerned shall be responsible for any damage claimed by any one on account of change of land use proposed.
3. The change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976. The change of land use shall not be used as the proof of any title of the land.
4. After approval of the change of land use the applicant have to apply to Visakhapatnam Urban Development Authority for necessary development permission duly paying the charges / fees to VUDA.
5. That the title and Urban Land Ceiling / Agricultural Land Ceiling aspect shall be scrupulously examined by the concerned authorities i.e., Visakhapatnam Urban Development

Authority/Greater Visakhapatnam Municipal Corporation before issue of building permission / development permission, and it must be ensured that the best financial interests of the Government are preserved.

6. The change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976.
7. Any other conditions as may be imposed by Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam.
