The draft variation to the land use envisaged in the Master Plan for Visakhapatnam issued in the Government Memo 3rd read above was published in the Extraordinary issue of Andhra Pradesh Gazette No.378, Part-I, Dated:13.10.2014. In the letter 5th read above the Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam has reported that the draft variation notification was published in two Daily News Papers, calling for objections & suggestions and upon publication of notification no objections and suggestions were received from the public within the stipulated period and also informed that the applicant has paid an amount of Rs.4,05,187/- towards land use conversion charges. Hence, the draft variation is confirmed.

APPENDIX
NOTIFICATION

The following variation to the land use envisaged in the Master Plan of Visakhapatnam which was sanctioned in G.O.Ms.No.345 M.A. & U.D. (H2) Department, dated:30.06.2006, is proposed in exercise of the powers conferred by Sub-section (2) of Section 12 of Andhra Pradesh Urban Areas (Development) Act, 1975 (Act-I of 1975) read with Rule 13-A of Urban Development Authority (Visakhapatnam) Rules, 1977 is hereby published as required by Sub-section (2) of the said Section.

VARIATION

The site falling in S.No.1/8p, 1/9, 1/10, & 2 of Sanivada (V), Gajuwaka (M) Visakhapatnam District to an extent of 3925.59 Sq.Mtrs., (Acs.0.97Cts.) the boundaries of which are given in the schedule below, which is presently earmarked for Greenbelt Use in Visakhapatnam Metropolitan Region, sanctioned in G.O.Ms.No.345 M.A. & U.D. (H2) Department, dt:30.06.2006 is now designated as Residential land use by variation of change of land use, as the proposed site is surrounded by residential activity and vacant lands subject to preparation of Road Development Plan (RDP) for the existing 9.15 mts approach road to make it 12.0 mts as was shown in Map.No.15/2014, Visakhapatnam Metropolitan Region which is available in the office of the Visakhapatnam Urban Development Authority, Visakhapatnam, subject to the following conditions; namely:-

1. That the applicant shall pay the development / conversion charges to the Visakhapatnam Urban Development Authority before issue of confirmation orders.
2. The Local Body shall prepare Road Development Plan (RDP) for existing 9.15 mts approach road to make it 12.0 mts.
3. That the applicant shall hand over the land for road widening if any, on free of cost to the concerned authority through Registered Gift Deed.
4. That the applicant shall obtain approval of building plans for construction of buildings from Greater Visakhapatnam Municipal Corporation, Visakhapatnam duly paying necessary charges to Greater Visakhapatnam Municipal Corporation, Visakhapatnam and Visakhapatnam Urban Development Authority, Visakhapatnam as per rules in force.
5. That the title and Urban Land Ceiling / Agricultural Land Ceiling aspect shall be scrupulously examined by the concerned authorities i.e., Visakhapatnam Urban Development Authority/Greater Visakhapatnam Municipal Corporation before issue of building permission / development permission, and it must be ensured that the best financial interests of the Government are preserved.
6. The owners / applicants are solely responsible for any misrepresentation with regard to ownership / title, Urban Land Ceiling Clearances etc. The owners / applicants shall be responsible for any damage claimed by any one on account of change of land use proposed.
7. After approval of the change of land use the applicant have to apply to Visakhapatnam Urban Development Authority for necessary development permission duly paying the charges / fees to Visakhapatnam Urban Development Authority, Visakhapatnam.

8. The change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976. The change of land use shall not be used as the proof of any title of the land.
9. The above change of land use is subject to the condition that may be applicable under the Urban Land Ceiling, Act, 1976 and A.P. Agriculture Ceiling Act.
10. Any other conditions as may be imposed by Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam.

- North : Existing building bearing Door No.3-81/6/2 of Smt. S.Vara Lakshmi, existing covenant church and Sri K.Sandya & Others in Sy.No.1/8P of Sanivada (V), Gajuwaka (M).
- East : Land belongs to Visakhapatnam Steel Plant authorities in S.Nos.8&9 of Sanivada (V) Gajuwaka(M)
- South : Proposed 100 Mts. wide logistic corridor.
- West : Existing building bearing Door No.3-18 of Sri S.Vijaya Kumar, existing 33' road and Land belongs to Visakhapatnam Steel Plant authorities in S.No.3 of Sanivada (V) Gajuwaka (M).
