VARIATION

The site falling in Sy.No.52/1p, Block No.4, Waltair Ward Visakhapatnam Urban (M), Visakhapatnam District to an extent of 576.93 Sq.Mtrs , the boundaries of which are given in the schedule below, which is presently earmarked for Residential use in the Master Plan of Visakhapatnam, sanctioned in G.O.Ms.No.345 M.A. & U.D. (H_2) Department, dated 30.06.2006, which is designated for Commercial use as shown in Master Plan No. 04/09 which is available in the office of the Visakhapatnam Urban Development Authority, Visakhapatnam, **subject to the following conditions; namely:-**

- 1. The applicant has to submit the proposals in the site under reference to the Authority concerned for approval.
- 2. The above change of land use is subject to the condition that may be applicable under the Urban Land Ceiling Act.
- 3. The owners / applicants are solely responsible for any misrepresentation with regard to ownership/title, Urban Land Ceiling Clearances etc. The owners / applicants shall be responsible for any damage claimed by any one on account of change of land use proposed.
- 4. The change of land use shall not be used as the proof of any title of the land.
- 5. The change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976.
- 6. The applicant shall obtain the approval of the building plans duly following the building rules in vogue for construction of commercial building from GVMC, duly paying the necessary charges to GVMC & VUDA.
- 7. Any other conditions as may be imposed by Vice Chairman, Visakhapatnam Urban Development Authority, Visakhapatnam.
