The Government of Andhra Pradesh, through Memo No. 1455449/M2/2021, MA&UD Department, dated 16.01.2025, has issued instructions to undertake a comprehensive revision of the Master Plan-2041, which was approved vide G.O.Ms.No.136, MA&UD Department, dated 08.11.2021, for the VMRDA area measuring 4380.67 Sq.Kms.
2. In accordance with the above orders, a notification dated 22.05.2025 was issued publishing the approved Master Plan-2041 and inviting objections and suggestions from the general public.
3. Pursuant to the said notification, all the objections and suggestions received by this office were duly examined, and based on the recommendations of the Technical Committee constituted by GoAP, necessary modifications were carried out to the Master Plan-2041.
4. The revised / updated Draft Master Plan-2041 is hereby published in accordance with Rule 16(3) of the Andhra Pradesh Metropolitan Region Development Authority Rules, 2018. The updated Draft Revised Master Plan-2041 shall be made available for public inspection at the VMRDA Office, free of cost, from 09.02.2026 to 10.03.2026.
5. Interested persons may submit their objections or suggestions, if any, on the updated Draft Revised Master Plan-2041 in writing to the Metropolitan Commissioner, Visakhapatnam Metropolitan Region Development Authority, on or before 10.03.2026.
