- 5. The bidder must be present at the time of open auction and opening of sealed tenders, failing which, EMD amount shall be forfeited by VMRDA, Visakhapatnam.
- 6. After completion of the Auction, the Sealed Tenders will be opened and highest bid offered out of the Auction-cum-Tenders will become successful bid subject to confirmation of MC, VMRDA.
- 7. The bid amount quoted by the bidder shall be above the upset price only, and otherwise it will be disqualified automatically.
- 8. The bidder can avail both the Tender and open auction option for bidding.
